TCHPB to send a letter to the Planning Department recommending that the property be added to the Teton County List of Historic Places. TCHPB offered to assist with the application process.

The Rocking H Ranch/Seaton Cabin at 6350 North Snake River Ranch Road, Wilson, Wyoming, is found to be historically significant according to the following Town of Jackson Designation Criteria:

1. Age
2. Architectural Integrity
3. Historical Significance

Therefore, I move to add the resource identified above to the Teton County Historic Preservation Board List of Historically Significant Resources.
