- Not well maintained
- Signs of water damage throughout the roof
- Signs of water damage in the interior
- Asbestos was removed
- Fallen into disrepair and has been vacant for a of couple years
- Property will be landscaped and maintained once structure is demolished

The resources identified in DEM23-0017 and located at 470 Teton Ave are found to be historically significant according to the Town of Jackson Designation Criteria to the Jackson Historic Register. However, the board does not recommended an issuance in the stay of demolition since the property has fallen into disrepair and is not a good candidate for relocation.
